1. Summary of our assessment

We have assessed that:

- Our **Second Home Purchase & Remortgage (H2ND)** product continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

2. Product characteristics & benefits

The products are designed to meet the needs of the target group, this being people who wish to buy or remortgage a 'second home'. The Society define a second home as a residential dwelling that an applicant resides in periodically, with no element of the property let out. The product features and criteria are designed to support these needs.

- A discount scheme for an initial period of 3 years. Discount to be applied to the Society's Standard Variable Rate (SVR)
- Available for new purchases, remortgages and mortgages on existing owner 'second homes'.
- Overpayments (monthly or lump sum) up to a total of 10% of the outstanding loan per year are allowed without charge.
- This mortgage is portable, subject to suitable security and underwriting assessment.
- An early repayment charge will be payable if the mortgage is redeemed within the first three years.

3. Target market assessment and distribution strategy

This target market assessment matrix segments the target customers for the Product, recognising their different needs to enable you to tailor the services you provide when you distribute the Product.

The Product is not designed for customers who:

- Are purchasing/remortgaging their main residence
- Are purchasing/remortgaging a property to let to tenants or on a short term let basis
- First time buyers
- Meet the FCA's definition of 'credit impaired'
- Do not meet our lending or property criteria
- Require a mortgage with no early repayment charges
- Require a fixed rate mortgage
- Require the ability to make unlimited overpayments

4. Customers with characteristics of vulnerability

The Product is designed for the market segment defined above, which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.

We consider the needs, characteristics, and objectives of customers with characteristics of vulnerability at all stages of the design process and have tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.

Specifically, for this product we have noted:

- Where an applicant takes a discounted product, they may be more susceptible to the challenges of a higher reversionary rate and payment once the initial product term expires.
- Where an applicant takes a product with an initial tie-in period to obtain a discounted pay
 rate, they are exposing themselves to the risk of having to pay an early repayment charge
 should, for any reason, they need to repay the mortgage in full before the end of the initial
 tie-in period.
- Remortgaging with additional capital raising may be indicative of issues managing outgoings or debt. The desire to release capital to service debt or everyday expenditure may lead to harms around choice of product and erosion of equity.

We have in place a framework to achieve good outcomes for vulnerable customers, which includes:

- Education and training for our staff to ensure they have the appropriate skills and experience to recognise and respond to the needs of vulnerable customers.
- Suitable customer service provision and communications.
- Flexible policies, where appropriate, to support vulnerable members.
- Monitoring to ensure we continue to meet and respond to the needs of customers with characteristics of vulnerability.

Intermediaries should continue to comply with your obligations to ensure that you treat customers in vulnerable circumstances fairly.

5. Our assessment of value
