We have assessed that:

- Our Fixed Rate product continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

**2. Product characteristics & benefits**

The products are designed to meet the needs of the target group, this being people looking to purchase a home in our Heartland Area (Cumbria, Lancashire, Tyne & Wear, County Durham, Northumberland, Yorkshire, Dumfries & Galloway and Scottish Borders. The product features and criteria are designed to support these needs.

- A fixed rate scheme for an initial period of 2 years, after which the Societies SVR will apply.
- Available for purchases only.
- Overpayments (monthly or lump sum) up to a total of 10% of the outstanding loan per year are allowed without charge.
- This mortgage is portable, subject to suitable security and underwriting assessment.
- An early repayment charge will be payable if the mortgage is redeemed within the first two years.

The Product is not designed for customers who:

- Are remortgaging their main residence.
- Are remortgaging or buying a property that is let to tenants or on a short term let basis.
- Are borrowing less than £50,000.
- Meet the FCA's definition of 'credit impaired'.
- Do not meet our lending or property criteria.
- Require a mortgage with no early repayment charges.
- Require a discounted rate mortgage.
- Require the ability to make unlimited overpayments.

### 4. Customers with characteristics of vulnerability

The Product is designed for the market segment defined above, which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.
